## **Allotment Inspection Update**

Cllr Garratt advised there is no update as no inspection has been undertaken, members agreed to carry out a full inspection of allotments on Wednesday 6th April at 6pm.

## **Allotment Waiting List**

There are four people on the waiting list and two free allotments, the Clerk to offer out the free allotments as soon as possible

The Clerk advised members that half allotments now occupy all but two full allotments on the top left hand side of the site.

#### Allotment AGM update

Cllr Mrs Mayor advised a notice has been put on the gate and in the notice board advertising the Extra Ordinary Meeting, unfortunately the letter that was promised on the 17<sup>th</sup> February was not forthcoming. The meeting is on Thursday 31<sup>st</sup> March at 7.30pm at the Falcon. Cllr Mrs Mayor advised the new notice board is in place, the key holders are Whittlesey Town Council and Mr Tom Owen, both sets of contact details are on the notice board. Members agreed to look at taking the old notice board down when they carry out the inspection.

Cllr Whitwell asked if Notice boards like this could be put in the villages, Cllr Mrs Mayor has requested that Mr Grey Esson visit the allotment site to see if the new allotment notice board would be suitable for the villages. Member agreed to add this item to the next projects agenda.

## Update on the Music Festivals on the Market Place.

The Clerk advised members that she still had not received confirmation from FDC for the dates of the fair and would chase as the bunting, barrier planters and hanging baskets are due to go up the same weekend, but may have to be delayed.
