P40/18. To consider Planning Applications received from FDC for comments including: - Questions for every planning application – Does it meet the criteria of the Cambridgeshire Fire and Rescue Service, building safe and designing out fire.

F/YR18/0015/F — Erection of a convenience store retail unit and 3 x 2 storey 3 bed dwellings and erection of 1.8 me (max height) boundary wall, involving the formation of new accesses and the demolition of existing building within a conservation area at Land North and West of 3-5 Low Cross, Whittlesey — This item is a misprint and should not have been included on the agenda as the recommendation has already been submitted.

F/YR17/1134/F – Erection of 3 x 2 storey dwellings including 1 x 3 bed with detached garage, 1 x 5 bed with integral garage and detached garden room involving demolition and removal of existing buildings within a conservation are at Land at Church Street Garage, Church Street, Whittlesey. Revised proposals: Revision is amended position of plot 3, amended width of garages, amended access to garages and additional parking spaces to plots 2 and 3.
