F/YR19/0031/F - Erection of a single storey extension to rear of existing dwelling involving removal of utility, bathroom and chimneys; and erection of a detached garage involved removal of existing garage at 47A Bassenhally Road, Whittlesey.

F/YR19/0051/F – Erection of a single storey extension to rear to existing dwelling involving the demolition of existing conservatory at 25 Drybread Road, Whittlesey.

The reason for my call to the Town Council was to have a chat and understand a bit more about what the town council's aspirations for the large area of open space which forms part of development. For example, is there any preference for the type of equipment to be installed within the LEAP and is there a desire from the Town Council for allotments to be included within the development.

In terms of the meeting it wasn't that I declined to attend a meeting with the Town Council as we are keen to engage with yourselves on this scheme. However, at this present time we do not have a finalised layout to bring along and discuss and hence a meeting would be premature. I would be more than happy to come along to your next committee meeting at which time I will be in a position to bring along a layout to discuss.

In the meantime, it would be most useful if you could advise of what your aspirations are for the open space within the site so we can then consider as part of the overall development. If it is useful, I will be more than happy to come to your offices to discuss in more detail.
