    not be granted a tenancy if the Council has a waiting list.
- Allotment Fees Members discussed the allotment rent and agreed to keep it at £48.00 per year for a full allotment and £24.00 for a half allotment, the water will be pro rata for the half allotments. The findings on water costs supplied by the Clerk highlighted that WTC have a much larger bill. The Clerk to check the Allotment water bills for the last five years and advise the Committee.
