March Fire Station also have these cameras, as they are based at March Fire Station, is there any reason why they cannot use theirs.

The Clerk will pose the questions to Cambridgeshire Search and Rescue (CamSAR) and advise if they can respond to the questions, the item can be considered at the next F & P meeting in October.
