# <u>F123/20 – Update from Mr Lee Baldry Interim Team Leader – Mayor Infrastructure Delivery – Kings Dyke</u>

Tonight's Full Council presentation offered as a proxy for the ongoing Local Liaison Meeting cycle, which will resume once lockdown lifted.

- CCC E&E, GPC, H&T Committees have each passed the King's Dyke scheme, variously being 5<sup>th</sup> March 23<sup>rd</sup> April and 7<sup>th</sup> June
- CCC now has a signed contract with Jones Bros, as per Press Release shared with WTC in May.
- Now we are moving into the mobilisation phase of the scheme.
- This is in parallel with technical design checks.
- There is a formal programme of works in place, which is being checked and challenged for robustness and expediency.
- There is a detailed risk register in place, which again is being robustly checked, challenged, and used in technical decision-making.
- There is a full governance procedure in place, the Terms of Reference for which were approved by E&E Committee 5<sup>th</sup> March.
- We are monitoring JB's performance as part of this governance process.
- There is a detailed Communications Plan in force, tied together with the programme of works.
- Some work is already ongoing onsite and underground Statutory Undertake work may be undertaken late July

Cllr Miscandlon – Asked if there will be a ceremony of any type – Due to Covid 19, this would be incorrect to call people to site, perhaps they may be a virtual ceremony, or leave it to later until COVID abates.

Cllr Gerstner- could there be a live feed of the project being built which could be live 24/7. Lee will take this back, he also advised they are discussing with Jones Brothers Drone flights throughout the project, another area would be time-lapse photography.

#### F124/20. Public Forum

To allow any member of the public to address the council. Time allowed 15 minutes in total to be split equally between the total amount wishing to speak.

Mr B Gray-Esson — VJ Day progress. He has written an article for The Fen's magazine and submitted it to Natasha Shiels for inclusion in the magazine. The act of remembrance will be held on 15<sup>th</sup> August at 11.00 at the Whittlesey Memorial. He is waiting to speak to someone senior from the RBL in July who will advise of the council scheme for the wreath.

#### F125/20. County Councillor reports

Cllr Boden- Continues to resist requests to reflood the fens to reduce the carbon omissions. They are having to explain that widespread planting of trees in fen areas is inappropriate because the effect of wide planting of trees in fen areas takes more moisture out of the soil thereby increasing carbon omissions, the wide spread planting of trees in the fens is does more harm than good.

CCC meeting in the future to discuss all road names in Cambridgeshire to ascertain any road names that may have association to the slave trade, these will then be changed.

Cllr Connor – was thanked by Cllr Miscandlon for getting the potholes filled from Coates through to Whittlesey.

Cllr Gerstner – expressed thanks to Cllr Connor for the removal of the elongated yellow lines on Ramsey Road.

### Growing Fenland Stakeholders Whittlesey Group - Cllr Mrs Dee Laws

Cllr Mrs Laws requested another member of the Town Council join the group as Cllr Bristow was our representative. Cllr Mrs Laws proposed Cllr Munns, this was seconded by Cllr Mrs Windle, with a unanimous vote in favour.

The first meeting was held last week, there were eight potential projects discussed, however the members need to look at capital expenditure and the ones that have come forward strongly are the heritage walk and cycle way, the heritage centre (Must farm) and great discussions about utilising the Buttercross and market place, whether it be enhancing marking stalls on a Friday, or perhaps a collectable and antiques day once a month, not of the same day as our existing market. The most important thing being we cannot be in competition with the existing shops.

Through the Growing Fenland Project, they are looking at better flood signage, (East Delph, Cemetery Road Roundabout and 2 on Kelly vision), 2.5 x 1.5-meter interactive signs with the cost being about 65K. The FDC officers are attending a meeting with the CPCA officers to learn more about how the bidding process works and how to apply for this funding and the dates associated with the bidding process.

They have five other projects to consider, these will be looked at in the future.

They have earmarked funds 500K for the heritage visitor centre 65 for the interactive signs but there may be additional costings which are unknown at this time. These can also be used for Kingsdyke, RTA's as well as the flooding.

### Past Mayor / Chairman's Medallion - Cllr Mason

Cllr Mayor presented members with the three quotations for 4 Mayor Medals, 6 Chairman, and 3 Combined.

- Toye Kenning £3237.44 with a presentation box
- Fattorini 2054.59 with no presentation box
- Crest Regalia 1140.90 with a presentation box.

Cllr Mason proposed the Town Council accept the quotation from Crest Regalia £1140.90, this was seconded by Cllr Miscandlon, with 2 votes against and the rest in favour, therefore making it a majority vote.

# Property Working Group - Grosvenor House - Cllr Mason

The property has now been handed back to owner, in accordance with lease we had to carry out some works, the original quotation was 5600.00, however the work required only came to 2750.00 this was virtually half of the original quotation.

#### Must Farm Heritage Centre - Cllr Mason

Cllr Boden is very keen that we obtain the capital finance for this programme from the county council capital scheme, this will leave more money in the Growing Fenland pot, he was disappointed that on the second attempt to attract funding the officer advised the bid needed more polishing. The officer wanted a greater proportion of the scheme to come from third parties, we do have the Growing Fenland Funding, the second item they were concerned about was the revenue that will take place. The Capital fund is only available on a first come first serve basis, the next panel is in two days' time.

There would be match funding to the value of 100K, which is the land that is being gifted by Forterra.
