- c. £2250. Election costs, this is low due to other elections taking place on the same day.

Cllr Boden advised a decision has been made on the procurement process for the heritage centre building, FDC will hold the budget however the funding agreement will be between CPCA and Whittlesey Town Council and not Fenland District Council.

Cllr Boden confirmed after changes to the budget and advised we should end of the financial year with a surplus of £23139.00. This was proposed by Cllr Boden, seconded by Cllr Mrs Mayor with a unanimous vote in favour. Cllr Boden will finalise the budget to accompany the minutes for Full Council.
