P33/2020. To consider Planning Applications received from FDC for comments including: - Questions for every planning application – Does it meet the criteria of the Cambridgeshire Fire and Rescue Service, building safe and designing out fire. (remove the para questions to end)

F/YR20/0262/F — Erect a 1.8m high (max height) close boarded boundary fence involving the demolition of existing 1.6m high fence within a conservation area (retrospective) at 30 Park Lane, Whittlesey.

The Town Council have no objection and therefore recommend approval.

F/YR20/0278/F - Erect a 2 storey side extension to existing dwelling at 16 Plough Road, Whittlesey.

<u>F/YR20/0354/TRTPO</u> – Works to a Yew tree and a Holly tree covered by TPO 3/2001 at The Vicarage St Marys Street, Whittlesey.

The Town Council have no objection and therefore recommend approval

F/YR20/0337/NONMAT – Non material amendment: variation of condition 17 to amend approved access drawing relating to planner permission F/YR16/1017/0 (Erection of 169 dwellings (max) (Outline with matters committed in respect of access only)) at site of former Eastfield Nursery, Eastfield Road, Whittlesey.

The Town Council recommend refusal due to the modification of the pedestrian Crossings, road layout that has now changed since the original planning application, we request that the planning department speak to CCC highways regarding these issues and request they review these amendments and update Whittlesey Town Council

<u>F/YR20/0357/0 – Erect up to 7432 sq m of B1 (c), B2 and B8 floorspace involving the demolition of existing buildings and dwelling (99 Kings Dyke) (outline application with matters committed in respect of access) at Churchfield Farm, Kings Dyke, Whittlesey.</u>

The Town Council recommend approval providing this has no detrimental effect on the Kings Dyke Bridge, we also request that the comments made by Anglian Water are taken into consideration when this application is determined.

F/YR20/0368/F – Erect a dwelling (2-storey 3-bed) and triple garage with erection of 1.2m high brick wall to front, involving demolition of existing barns at Barns West of 60 South Green Coates.

The Town Council have no objection and therefore recommend approval

<u>F/YR20/0389/TRCA – Felling of 2no. Beech Trees within a conservation area at 11A Broad Street, Whittlesey.</u>

The Town Council recommend refusal until the tree officers report has been sent to the ward Cllr Mrs Julie Windle.

F/YR20/0406/TRTPO - Works to 1no Beech Tree covered by TPO 1/2006 at 26 Mill Road, Whittlesey

The Town Council request that any works carried out are completed subject to consultation with the tree officer at Fenland District Council
