I am writing to inform you that Fenland District Council is consulting on the Draft Local Plan, the second stage in the preparation of a new Local Plan for Fenland. This is an important document as it will determine what the district will look like in the future and how it will become an even better place to live, work and visit. The Draft Local Plan sets out criteria-based policies that address the key issues in the district. It also includes specific allocations for new development.

Consultation on the draft Local Plan will take place between **25 August 2022 and 19 October 2022**. Full details are available on our website at:
