CP40/2023. To confirm and sign minutes from the last meeting of the Community Projects Committee held on Wednesday 2nd August 2023.

CP43/2023. Agenda items for discussion.

1. Community Projects remit – Defer to November meeting.
2. Allotment Update – The Clerk advised evictions were ongoing, some people wish to retain their allotment, but these will be monitored and if no improvement is seen, they the eviction process will continue. There is 30 people on the waiting list.
3. Community Payback Team Projects – Cllr Mockett asked the Clerk to send email to all Cllrs asking for projects the payback team can complete. The Clerk will collate the list.
4. Hanging basket Water tenders – The Clerk advised she will be working on the tenders.
5. Green Dog Walkers Scheme – The Clerk to ask Robin Sutton to come to the next Projects meeting to give brief talk on the dog walkers scheme and how it works.
6. Heritage Project - Cllr Black will be asked to present this to the Full Council with a proposal of how we move forward.
7. Market Place Planters – Cllr Mayor advised we can use the water in the market place if these are planted, it was suggested that businesses are approached to sponsor these but would also have to maintain them. Cllr Mrs Mayor will speak to FDC about potential planting, she did suggest a hardy fuchsia in the centre, surrounded by bulbs. The Clerk to obtain a price a full colour A5 sign for each planter that will advertise the sponsor.



8. Music Events 2024 – 23rd June, 21st July, 11th Aug, 15th Sept. The Clerk to check price and availability with all the bands, Cllr Mockett suggested that the June event may be at the Manor, July and August on the Market Square and September in Coates.
