

## **WHITTLESEY TOWN COUNCIL - Planning Committee**

Minutes of meeting held on Monday 11<sup>th</sup> May 2026 at 7:30pm at Peel House, 8 Queen Street, Whittlesey, PE7 1AY.

**Present:** Councillors Miscandlon, Bibb, Dickinson, Laws, Nawaz and Wainwright.

### **P162/ 2026. To receive apologies from absence members and the reason for the absence.**

**Councillor Arman-** No apologies received.

Councillor Laws in fact left the room as she declared a non-pecuniary interest in the application F/YR26/0196/PIP, rather than it being a family member.

**Councillor Miscandlon** signed the minutes of the meeting held on Monday 27<sup>th</sup> April 2026 as a true and correct record.

### **P165/2026. Public Forum**

Councillor Gerstner addressed the council about scaffolding at 2-4 Barr Street (between Market Street and Church Street) that is allegedly not compliant. A member of the public contacted multiple entities (Police, County Council, Highways, Health and Safety, Fenland District Council and Councillor Gerstner) on 23<sup>rd</sup> April regarding the scaffolding.

Councillor Gerstner contacted multiple Councillors and departments on multiple occasions since the 23<sup>rd</sup> April. A first email was received on the 8<sup>th</sup> of May, apologizing for the delay and stating that the matter is being escalated as there had been no response.

Councillor Gerstner requests that the council send a letter to the chief executive of Cambridgeshire County Council, regarding the poor communication about the incident.
